



RATING AND CHARACTERISTIC CURVES BAS516







Fig.6 Reverse Recovery Voltage Test Circuit and Waveforms


SAMPLING OSCILLOSCOPE $R_i = 50 \Omega$



Fig.7 Forward Recovery Voltage Test Circuit and Waveforms






