



Device Schematic








Figure 2. ESD Discharge Current Waveform IEC 61000-4-2 (330Ω/150pF)








Figure 3. Power Dissipation vs. Pulse Time










Figure 7. Clamping Voltage Characteristics (tp =  $8/20\mu s$ )










