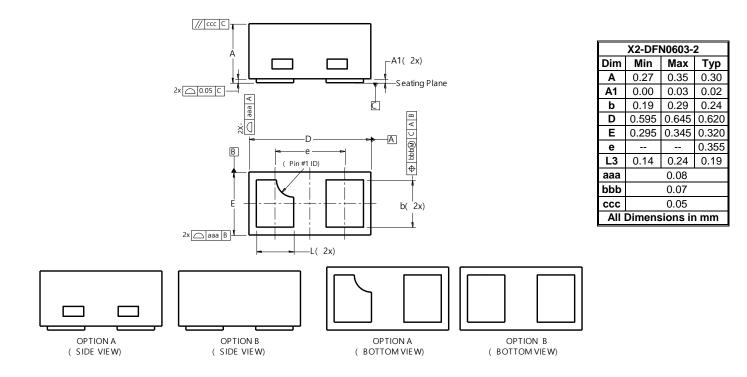




Package Outline Dimensions

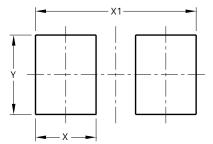
