




**Bottom View**










Figure 8. Gate Threshold Variation vs. Junction Temperature



V<sub>DS</sub>, DRAIN-SOURCE VOLTAGE (V) Figure 10. Typical Junction Capacitance









Figure 13. Transient Thermal Resistance


