

RATING AND CHARACTERISTIC CURVES MBR3045CTW






FIG.3- TYPICAL FORWARD CHARACTERISTICS




FIG.4- TYPICAL JUNCTION CAPACITANCE





FIG.5- TYPICAL REVERSE CHARACTERISTICS


