

RATING AND CHARACTERISTIC CURVES MBR30H100CT





FIG.3 - TYPICAL REVERSE CHARACTERISTICS



VERSE VOLTAGE (%)




FIG.4 - TYPICAL FORWARD CHARACTERISTICS





FIG.5 - TYPICAL JUNCTION CAPACITANCE


