

RATING AND CHARACTERISTIC CURVES SB5100




FIG.2- MAXIMUM NON-REPETITIVE SURGE CURRENT




FIG.3- TYPICAL FORWARD CHARACTERISTICS

CASE TEMPERATURE, (°C)






FIG.4- TYPICAL JUNCTION CAPACITANCE




