



100V INPUT, DUAL OUTPUT VOLTAGE REGULATOR PowerDI5060-8

Description

The ZXTR1135PD8 is a high voltage regulator with fixed dual outputs of 5V and 13V giving up to 50mA drive per channel. It is designed for use in high voltage applications where standard linear regulators cannot be used. This function is fully integrated into a PowerDI 5060-8 (Type B) package, minimizing PCB area and reducing number of components when compared with a multi-chip discrete solution. The high voltage regulator can deliver up to 100mA output current (Note 1).







Pin Functions

Pin Name	Pin Function	Notes
V _{IN}	Input Supply	To maintain output regulation the input voltage can vary from 18 to 100V with respect to the GND pin. It is recommended to connect a $1\mu F$ capacitor to GND.
GND	Power Ground	This pin should be tied to the system ground.
5V _{OUT}	5V Output	Outputs a regulated 5V when drawing between 0.1 to 50mA current. It is recommended to connect a ≥100nF capacitor to GND to minimize the noise on the regulated output.
13V _{OUT}	13V Output	Outputs a regulated 13V when drawing between 0.1 to 100mA current. It is recommended to connect a ≥100nF capacitor to GND to minimize the noise on the regulated output.


Typical Application Circuit



Example of a 5V and 13V regulated supply from a nominal 48V for powering two Controller IC's.




5V_{OUT} Typical Electrical Characteristics (@T_A = +25°C, unless otherwise specified.)





13V_{OUT} Typical Electrical Characteristics (Cont.) (@T_A = +25°C, unless otherwise specified.)




