




FIG.3- TYPICAL FORWARD CHARACTERISTICS




FIG.5- TYPICAL REVERSE CHARACTERISTICS




FIG.2 MAXIMUM NON-REPETITIVE SURGE CURRENT






FIG.4- TYPICAL JUNCTION CAPACITANCE


