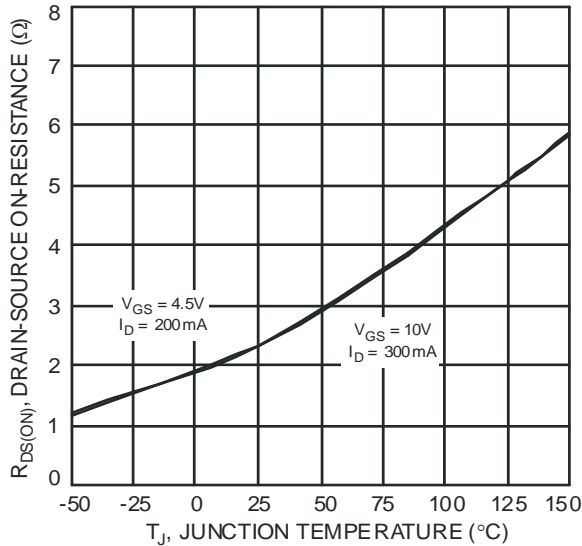


Figure 7 On-Resistance Variation with Temperature

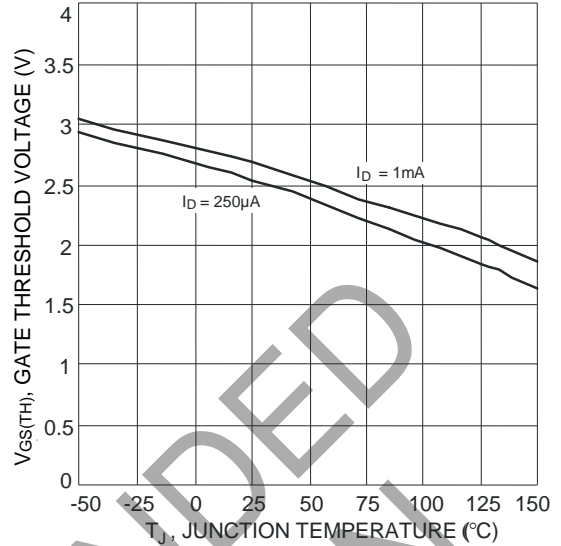


Figure 8 Gate Threshold Variation vs. Junction Temperature

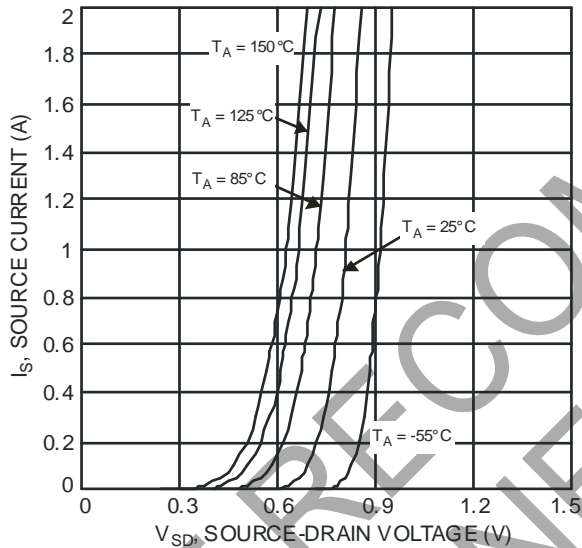


Figure 9 Diode Forward Voltage vs. Current

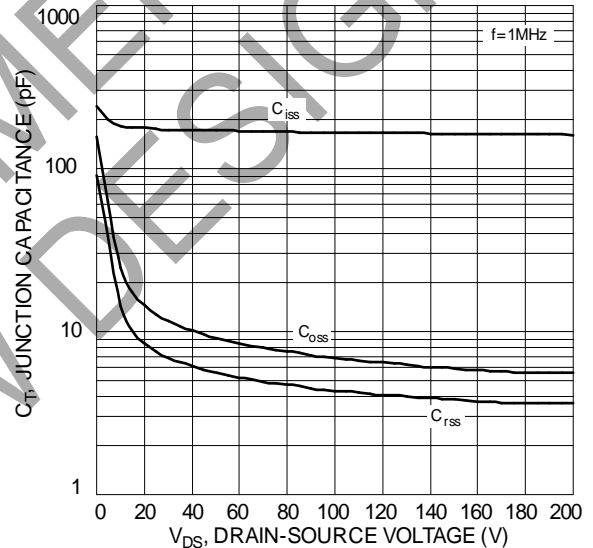
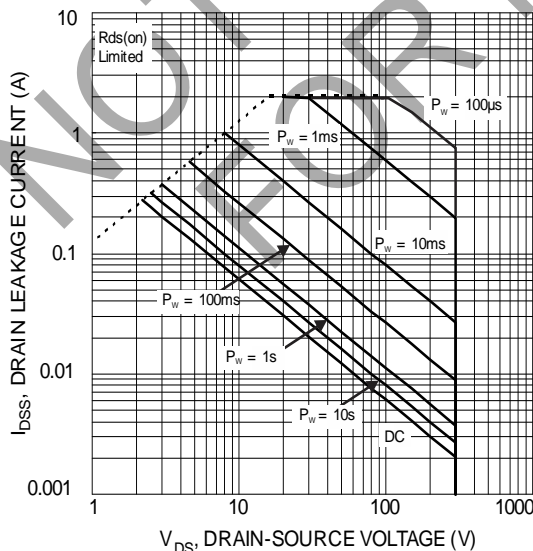


Figure 10 Typical Junction Capacitance



Note 11 Typical Drain-Source Leakage Current vs. Voltage

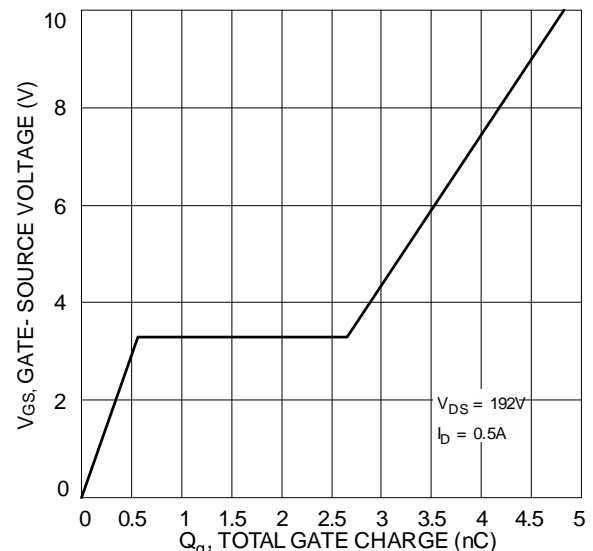
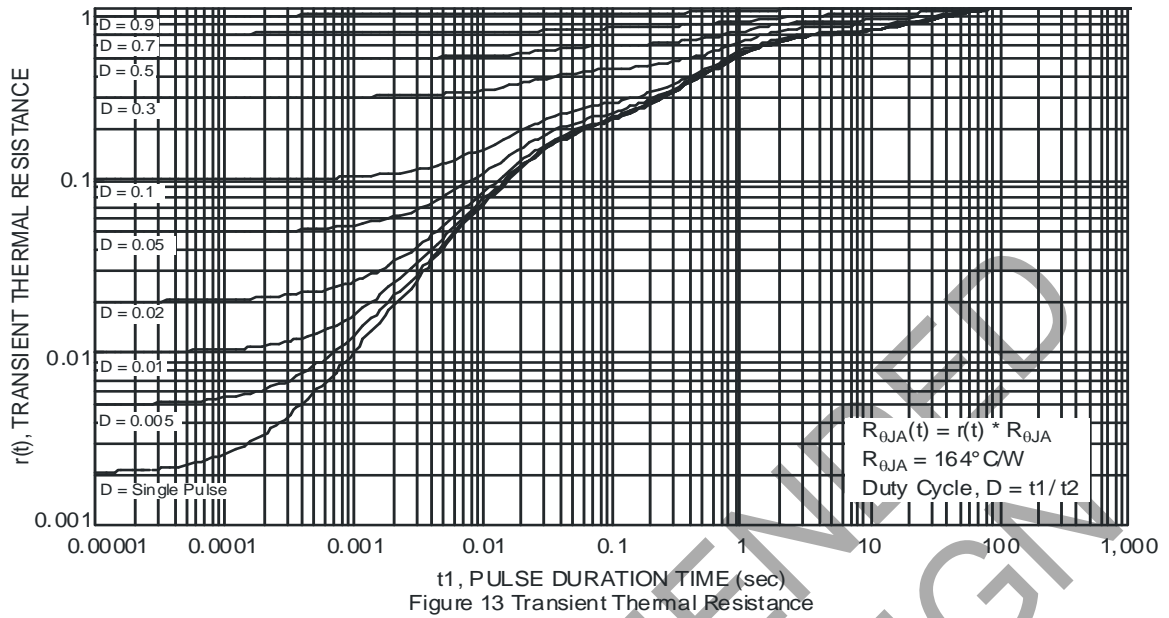


Figure 12 Gate Charge

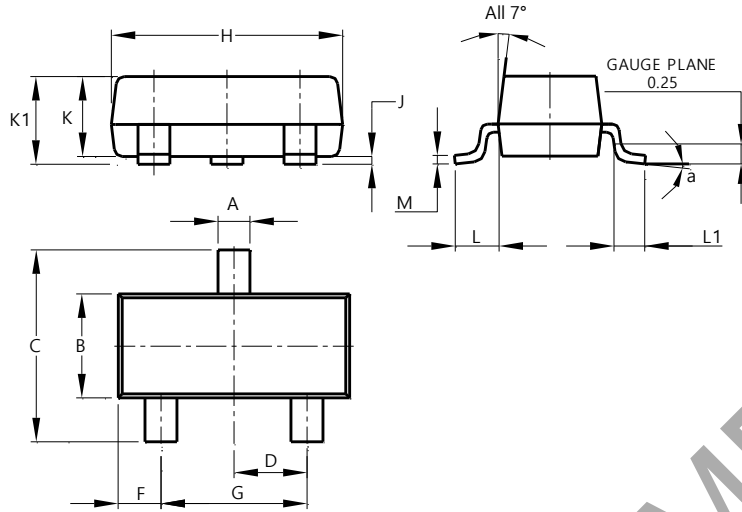

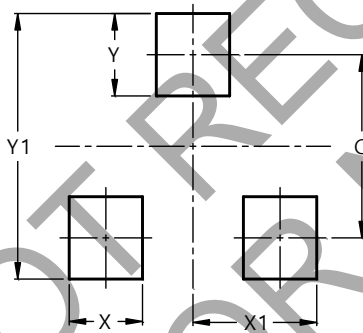
