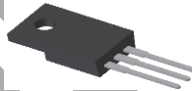

Top View



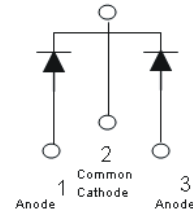

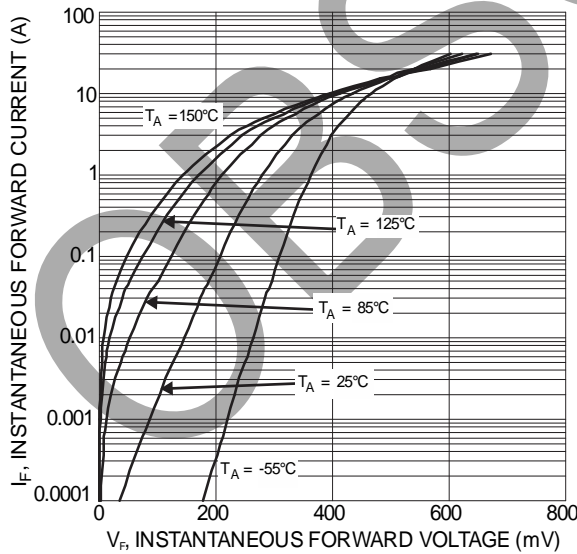


Figure 1 Typical Forward Characteristics

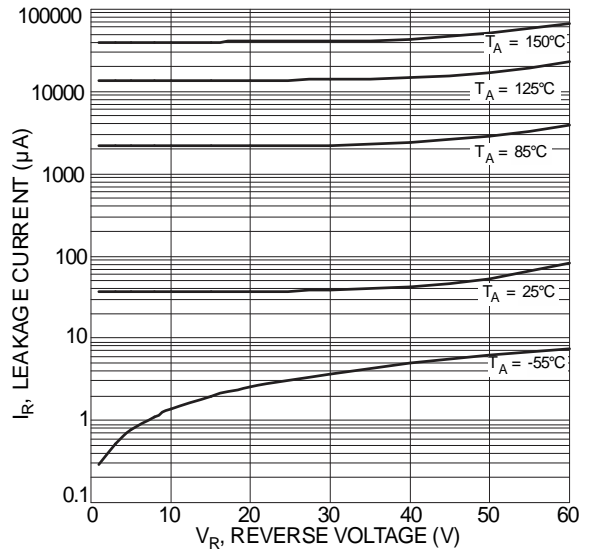


Figure 2 Typical Reverse Characteristics

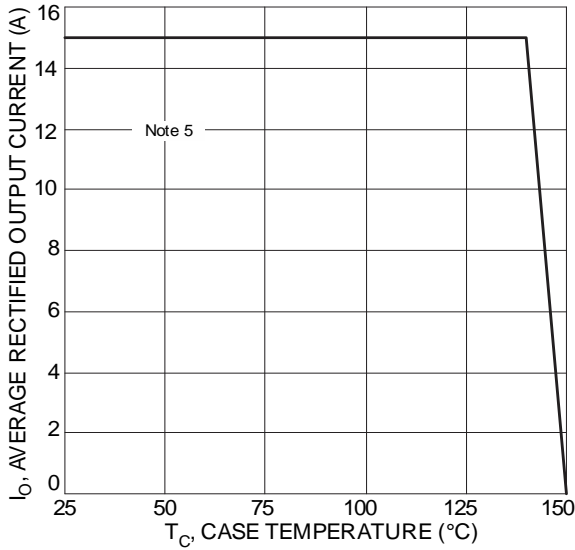


Figure 3 DC Forward Current Derating

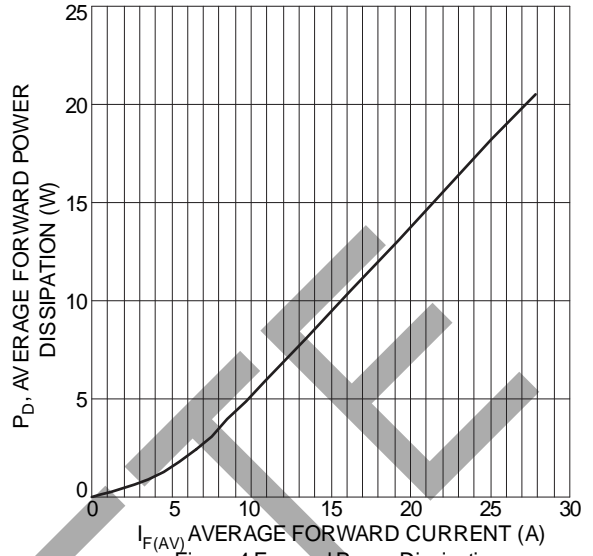


Figure 4 Forward Power Dissipation

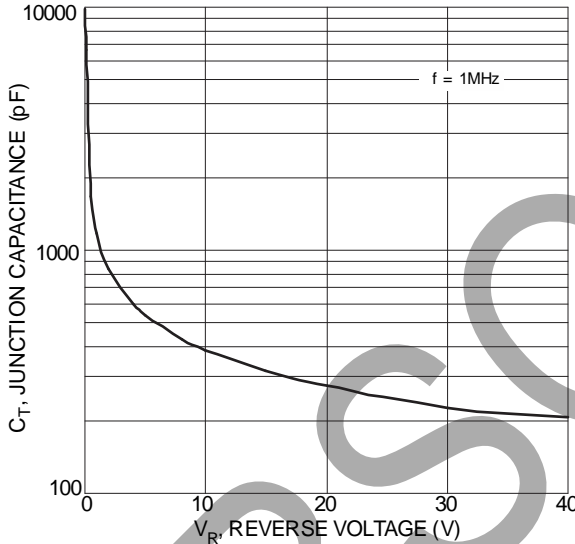
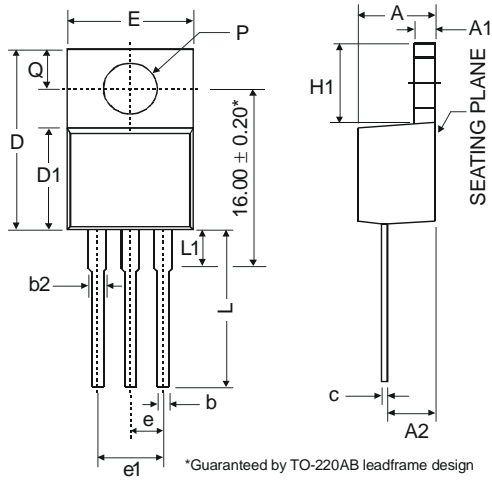


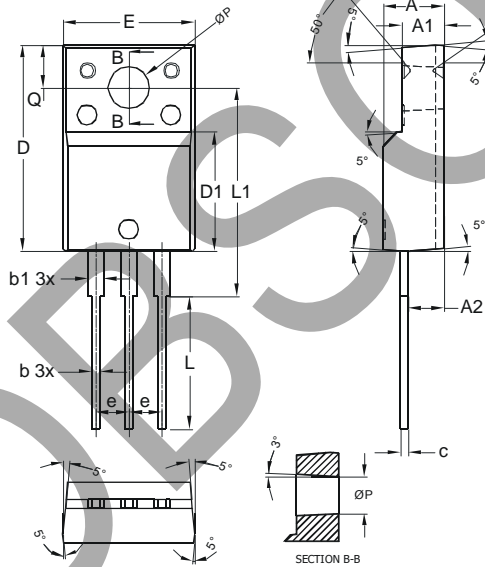
Figure 5 Typical Junction Capacitance
