


Fig 1. Safe Operating Area




Fig. 2 Transient Thermal Impedance




Fig. 3 Transient Thermal Impedance




Fig. 4 Pulse Power Dissipation




Fig. 5 Derating Curve





Fig. 6 Timing Waveform






Fig. 15 Switching Performance





Fig. 14 $R_{CE(sat)} v T_{amb}$


