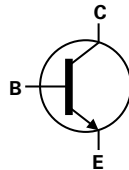

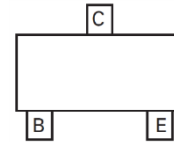

Device Schematic



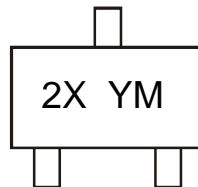
Package Pinout Configuration

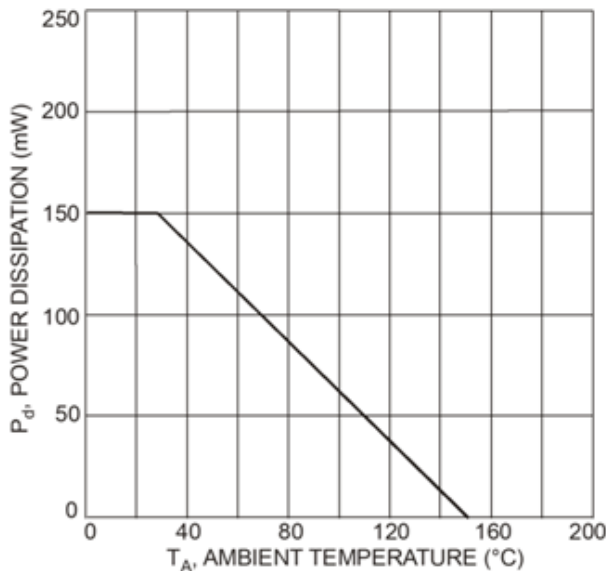


Fig. 1 Power Derating Curve

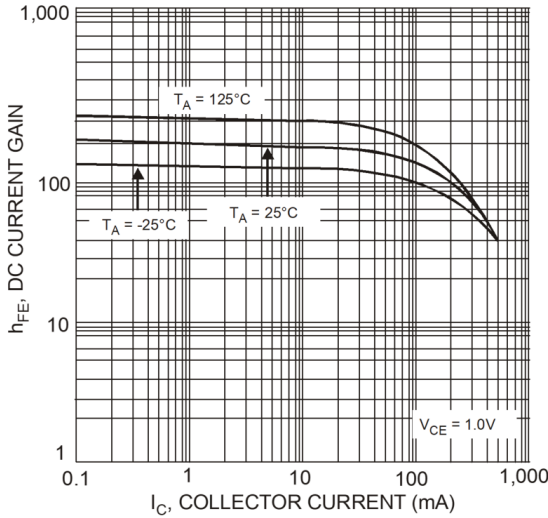


Fig. 2 Typical DC Current Gain vs. Collector Current

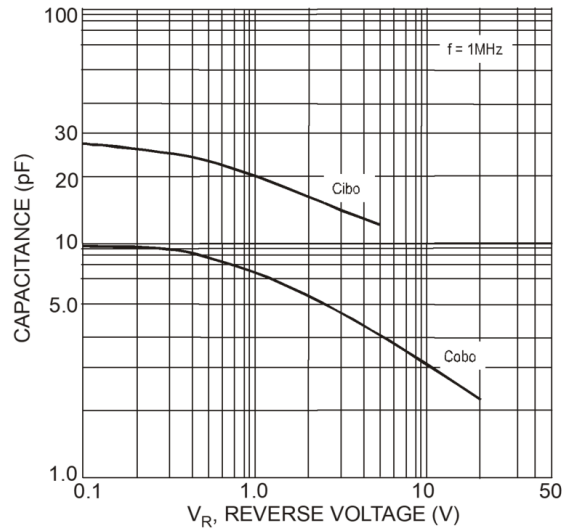


Fig. 3 Typical Capacitance

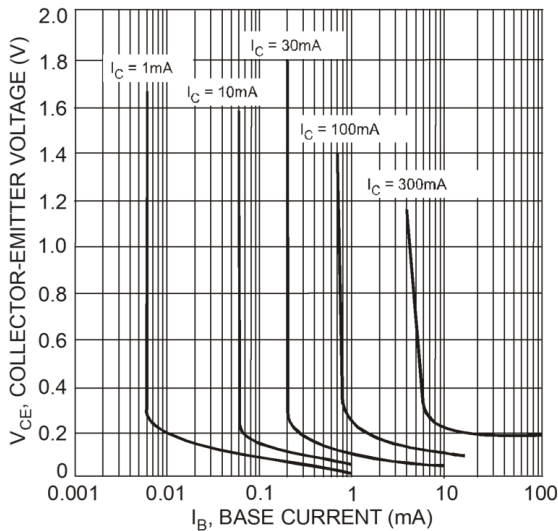


Fig. 4 Typical Collector Saturation Region

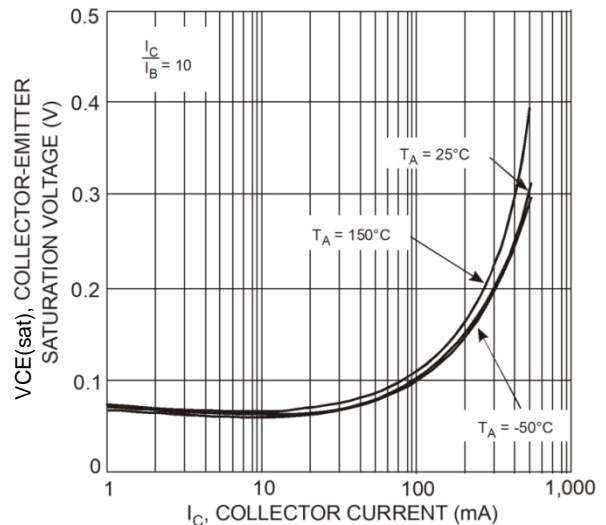


Fig. 5 Typical Collector Emitter Saturation Voltage vs. Collector Current

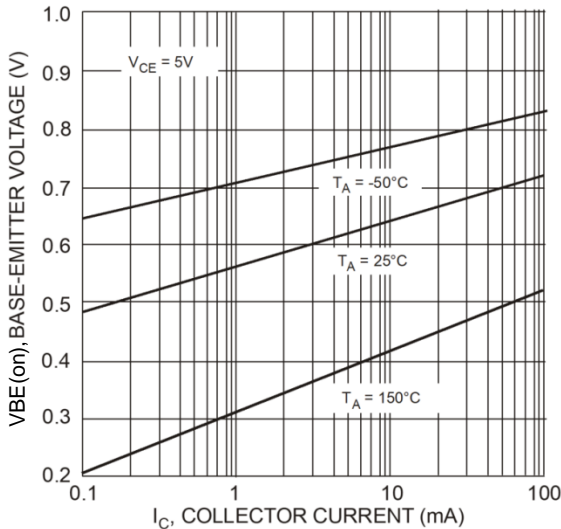


Fig. 6 Typical Base-Emitter Voltage vs. Collector Current

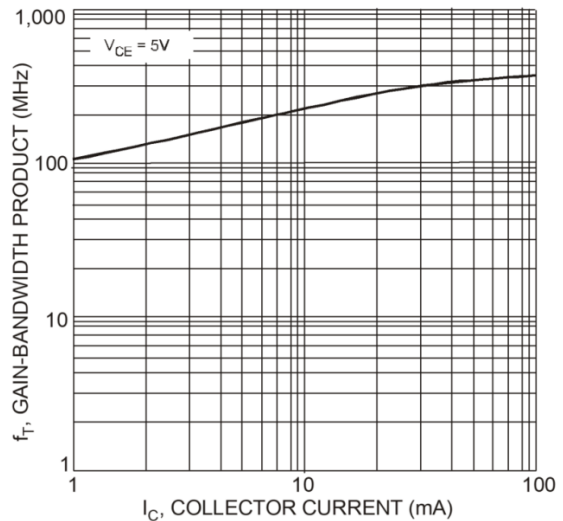
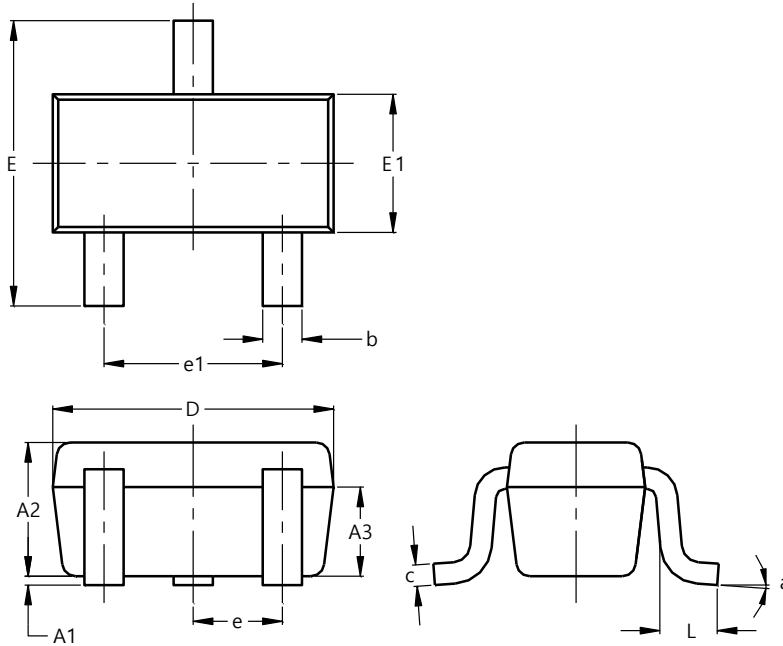


Fig. 7 Typical Gain-Bandwidth Product vs. Collector Current

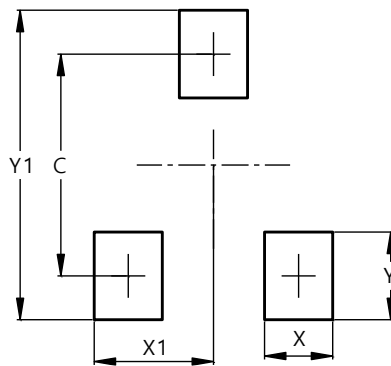
