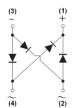

Internal Schematic

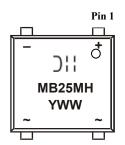

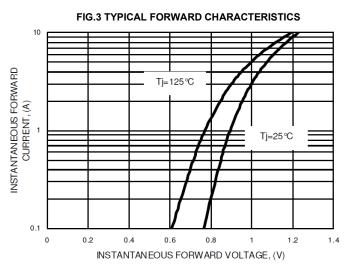


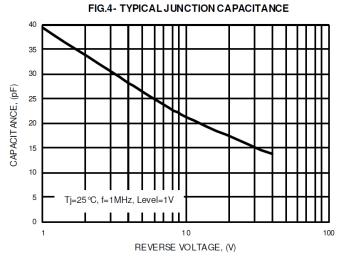


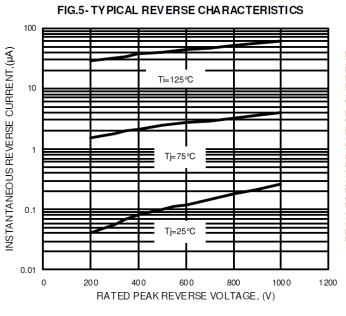


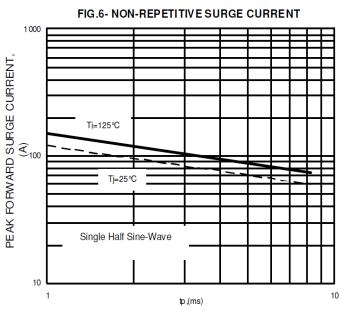
NUMBER OF CYCLES AT 60Hz

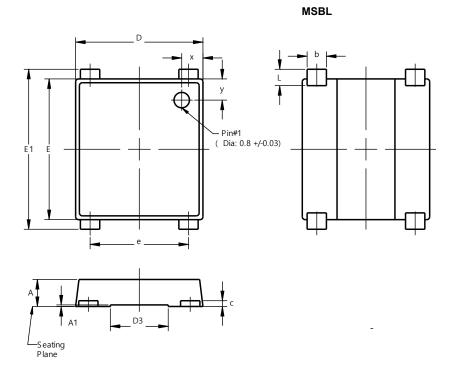

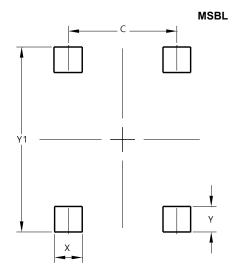
