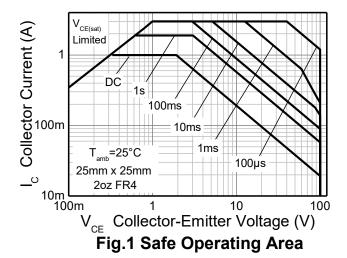

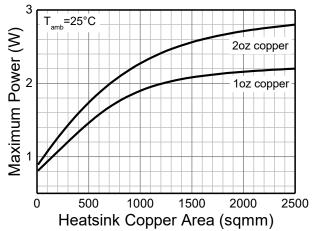
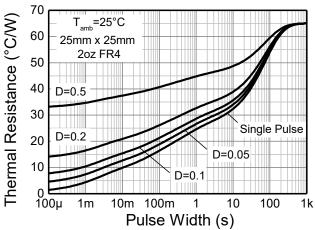


Fig.2 Max Power Dissipation vs. Copper Area



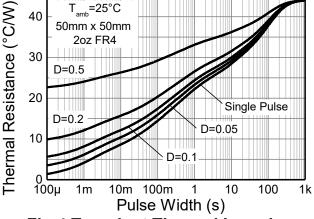
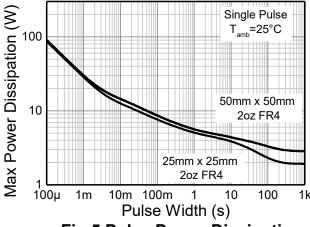


Fig.3 Transient Thermal Impedance

Fig.4 Transient Thermal Impedance



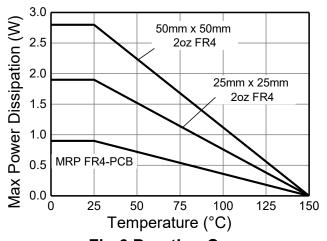


Fig.5 Pulse Power Dissipation

Fig.6 Derating Curve



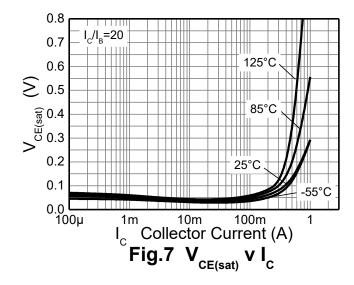

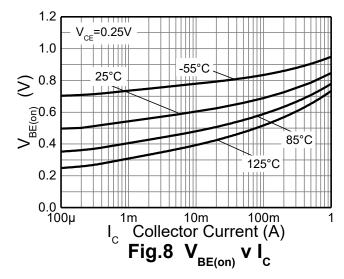

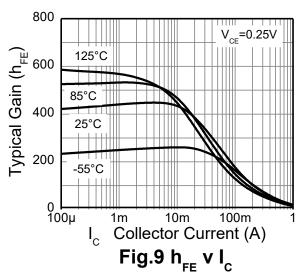

Typical Electrical Characteristics (@TA = +25°C, unless otherwise specified.)







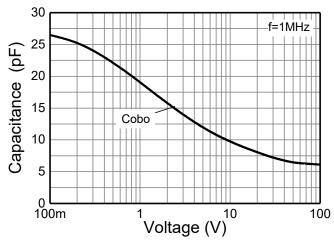


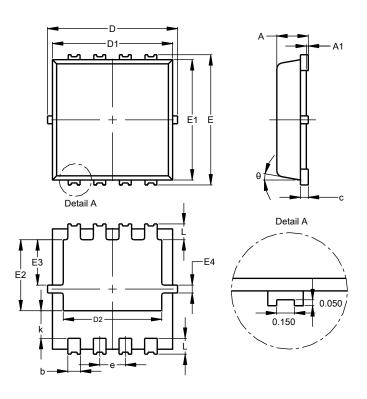
Fig.10 Capacitance v Voltage

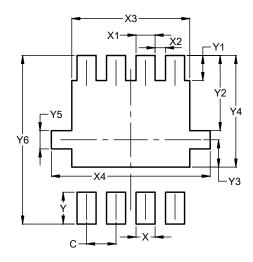
